#### APPLICATION INSTRUCTIONS:

Method

Brush, Roller, Airbrush gun, Air-Less, until wet out the surfaces.

If necessary use water.

Cleaning

After use, clean all equipment with plenty water, if is possible with pressured water.

## **SURFACES PREPARATION:**

Wood and metal must be dry, clean of cement dust, removing remnants of previous released, grease, dirt, strange objects, etc. The product should be applied in one or two layers according to wood adsorption or the desired thickness to be applied to the metal. Wait 30 minutes before place the concrete.

### **Precautions**

- Should not apply excessive amounts because they can produce spots in the concrete.
- Ensure that the application is homogeneous across the surface of the casing, extending crosswise.
- The manipulation must be done with rubber gloves and safety glasses.

#### **HYGIENE AND SECURITY:**

- Non-flammable product.
- If applied by spray mask is recommended.
- It should not apply in very cold weather where there are temperatures below or close to -2 ° C.
- Preserves the paint can from frost.
- If the product splashes eyes, rinse with clean water several times without scrubbing; always consult your doctor or the National Institute of Toxicology, Phone Number 91 – 562.84.69.
